# **Training Fees**

\$11 per session, paid as a term fee upfront.

If swimmers swim more than 2 days a week or a family has more than 2 children swimming the following applies:

#### Family with 1 swimming member:

2 Sessions full price (\$11 a session), based on highest session count in the term, all extra sessions half price (\$5.50 a session)

#### Family with 2 swimming members:

4 Sessions full price (\$11 a session), based on highest session count in the term, all extra sessions half price (\$5.50 a session)

#### Family with 3 swimming members:

1st Session full price (\$11 a session), based on highest session count in the term, all extra sessions half price (\$5.50 a session)

Family with 4 swimming members: 1st Session full price (\$11 a session), based on highest session count in the term, all extra sessions half price (\$5.50 a session)

Please Note: If you cannot attend a lesson it is up to the individual to make up the lesson on an alternative swim day within that term and to advise the coach, that it is a makeup lesson. No fees are refunded for days missed.
